Welsh IG Toolkit

Registration Support for General Practitioners

Navigating to the Platform

In 2023 the Welsh IG Toolkit transitioned onto a new platform called Caforb, you will be required to register for a new account on the Caforb platform.

To get started on the platform, an individual within the practice will be required to register as the Organisation Administrator.

The Organisation Administrator has the ability to complete and submit the IG Toolkit and is responsible for maintaining the Organisation Profile, Creating Users and controlling access to the Organisation's IG Toolkit Form.

Only one Organisation Administrator can be set up for each organisation. If changes need to be made to the Organisation Administrator for your organisation, please contact the [Welsh IG Toolkit Team](#).

To register for an account as an Organisation Administrator visit the [Caforb Platform site](#) and select 'Register'.

Registering your Practice for the Welsh IG Toolkit

You will be taken to the registration page once you have completed the steps above.

Your account

This section will need to be completed at this stage as all these fields are mandatory. This is so that your account can be created with the correct details. You can register using any email address, your email address used at this stage will become your username in order to access the platform moving forward.

Organisation Details

This section is where you will need to search for and select the practice that you are registering to be the organisation administrator for.

You can search for your practice by W code or name. For example, W123456.

Once you have found your practice in the list, you can select it and it will then show the details for the practice to the right of the search box.

Organisation Profile

These fields do not have to be filled in at this point, however we do recommend you populate these now as you it will save time having to revisit this later within the platform.

Once you have completed these sections click the 'Submit' button. This will then send a notification to the IG Toolkit Team who will process the request. The team aim to have this done as quickly as possible; you will receive a notification once this is approved/rejected.

If your account is approved, you will receive an email to set your password. Your password must be at least 11 characters in length and weak passwords will not be accepted.

Once you have set your password you will be able to log in to the platform using the email address used in the registration process as your username.

Adding the Clinical Governance Toolkit (CGPSAT) within Caforb

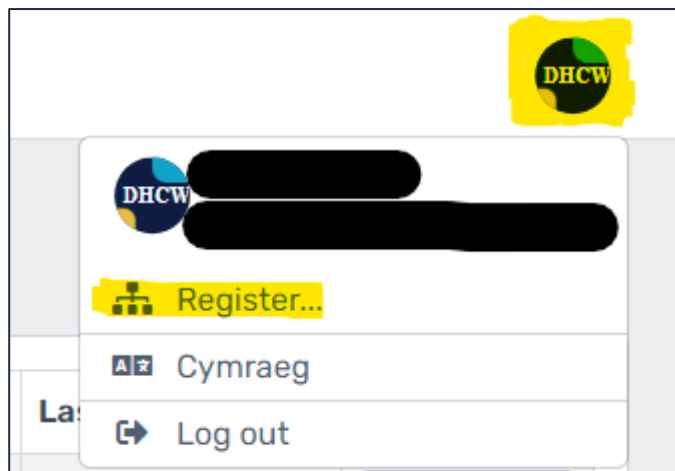
Once you have registered to be an organisation administrator for the Welsh IG Toolkit, you will be able to log into the platform using the same Caforb Platform link shown at the start of this guidance. Your username will be the email address you used to register your account.

As of this year, the CGPSAT will also be hosted on the Caforb platform. Once you have registered for the Welsh IG Toolkit, you will also need to register for the CGPSAT. To do this you firstly need to log into the Caforb platform.



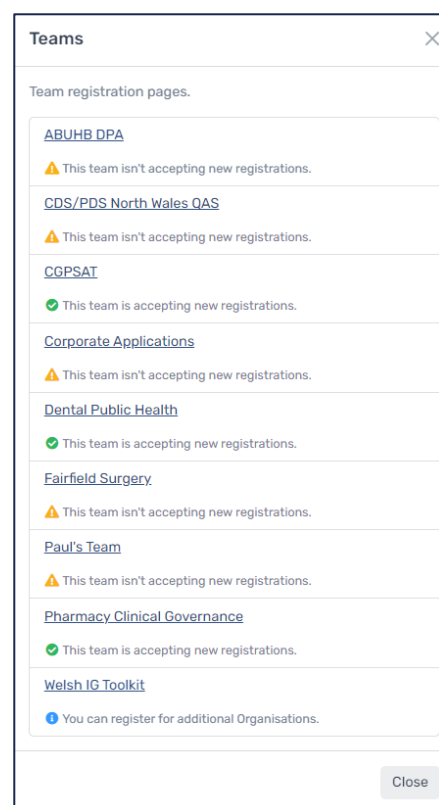
Once signed in, click the circle icon in the top right of the screen and then select 'Register' as highlighted in the image.

Once you select to 'Register', you will be presented with a list of Teams that are available on the Caforb platform. To register for the CGPSAT, you will need to select 'CGPSAT'.



You will then be taken to a registration page like the one when you originally registered for the Caforb platform. However, this will now have the 'Your account' section already populated. You will now just need to search for the organisation you would like to register for the CGPSAT.

Your registration request will be sent to the CGPSAT Team for approval. Once approved, you will see both the "CGPSAT" and "Welsh IG Toolkit" Teams on the lefthand navigation bar. Select "Forms" of the relevant Team to begin completing the respective Toolkit, or "Organisation Management" to edit user access to each form.



Registering for the CGPSAT Only

This section applies if you are registering directly for the CGPSAT and not the Welsh IG Toolkit.

To get started on the platform, an individual within the practice will be required to register as the Organisation Administrator.



The Organisation Administrator has the ability to complete and submit the Clinical Governance Toolkit and is responsible for maintaining the Organisation Profile, Creating Users and controlling access to the Organisation's Clinical Governance Toolkit Form.

Only one Organisation Administrator can be set up for each organisation. If changes need to be made to the Organisation Administrator for your organisation, please contact the CGPSAT Team.

You will be taken to the registration page once you have completed the steps above.

Your account
