Indicator

The percentage of assessments undertaken within (up to and including) 56 days from the date of receipt of referral. This will reduce to 28 days from the date of receipt of referral from data submitted for October 2013 onwards.

Target:

80% - the target is monitored by individual Local Health Board (LHB).

Rationale / Context

The Mental Health (Wales) Measure 2010 will ensure appropriate care is in place across Wales which focuses on people's mental health needs. It places new legal duties on Local Health Boards and Local Authorities about the assessment and treatment of mental health problems and improves access to independent mental health advocacy for people with mental health problems.

The measure has four main parts. This indicator relates to Part 1 which will ensure that more mental health services are available within primary care. It requires Local Health Boards and Local Authorities to work together to establish Local Primary Mental Health Support Services (LPMHSS) across Wales. This service will be delivered within and alongside GP settings and will provide:

- assessment
- short term interventions
- information, advice and
- onward referral to other services, where appropriate.

Section 48 of the Measure places a 'duty to review' upon Welsh Ministers within 4 years of the implementation of the Measure.

Mental Health (Wales) Measure 2010 Data Collection – Part 1.

Definitional Guidance:

The Mental Health Measure Part 1 Proforma is an aggregate data collection. Whereas more complex methodologies could be applied to patient-level data sets, in this case, extensive definitional guidance has been provided to LHBs to enable them to determine the content of their aggregate returns. The central 'analysis' of these returns is then comprised of the straightforward selection of relevant counts for onward presentation.

Detailed Specification

An assessment may be face to face or by telephone and will include assessments with parents or carers

in relation to the individual who has been referred, either with or without that individual being present. It will exclude any preliminary telephone contact to establish whether the individual wishes to have an assessment. The assessment is an evaluation of the nature of a patient's mental health needs.

The waiting time starts at the point when a referral is received by the LPMHSS.

Calculation:

Numerator

Number of assessments undertaken during the month where the patient had waited up to and including 56 days from the date of receipt of referral to the assessment.

From October 2013 data onwards:

Number of assessments undertaken during the month where the patient had waited up to and including 28 days from the date of receipt of referral to the assessment.

Denominator

Total number of assessments undertaken during the month.

Reporting Frequency

Aggregate returns are submitted monthly to Welsh Government by Welsh LHBs / Trusts by the last calendar day of each month. If this falls on a weekend, then it will be the next working day following the weekend.

Publication of performance also takes place on a monthly basis.

Areas for Future Development

The following points reflect considerations raised by either the Analysis Methodologies Group or WISB in terms of aspects of the Analysis Method that require further investigation or development.
