Indicator

The percentage of LHB residents, in receipt of secondary mental health services (all ages), who have a valid Care and Treatment Plan (CTP).

Target:

90% - the target is monitored by individual Local Health Board (LHB).

Rationale / Context

The Mental Health (Wales) Measure 2010 will ensure appropriate care is in place across Wales which focuses on people's mental health needs. It places new legal duties on Local Health Boards and Local Authorities about the assessment and treatment of mental health problems and improves access to independent mental health advocacy for people with mental health problems.

The measure has four main parts. This indicator relates to Part 2 which ensures all patients in secondary Mental Health services will have a valid CTP. It places duties on Local Health Boards and Local Authorities in Wales to work together to ensure that people of all ages within secondary mental health services have a care co-ordinator and a care and treatment plan that is reviewed at least yearly.

Section 48 of the Measure places a 'duty to review' upon Welsh Ministers within 4 years of the implementation of the Measure.

Definitional Guidance:

The Mental Health Measure Part 2 & 3 Proformas are both aggregate data collections. Whereas more complex methodologies could be applied to patient-level data sets, in this case, extensive definitional guidance has been provided to LHBs to enable them to determine the content of their aggregate returns. The central 'analysis' of these returns is then comprised of the straightforward selection of relevant counts for onward presentation.

Detailed Specification

A valid CTP is a current, in date, Care and Treatment plan as defined in Part 2 of the Mental Health Measure.

Secondary Mental Health Services relates to services provided by secondary mental health and not included in LPMHSS schemes. They are defined as:

- (a) a service in the form of treatment for an individual's mental disorder which is provided under Part 1 of the National Health Service (Wales) Act 2006;
 - (b) a service provided under section 117 of the Mental Health Act 1983;
 - (c) A community care service, the main purpose of which is to meet a need related to an adult's mental health;
 - (d) A service provided for a child under Part III of the Children's Act 1989, the main purpose of which is to meet a need related to that child's mental health; and
 - (e) A service in the form of treatment for an individual's mental disorder includes a service that, in the opinion of the person providing or making arrangements for the provision of the service, is intended to treat a mental disorder that the individual receiving the service is suspected to have.

Calculation:

Numerator

Total number of patients resident in an LHB with a valid CTP at the end of the month.

Denominator

Total number of patients resident in an LHB in receipt of secondary Mental Health services at the end of the month.

Reporting Frequency

Aggregate returns are submitted monthly to Welsh Government by Welsh LHBs / Trusts by the last calendar day of each month. If this falls on a weekend, then it will be the next working day following the weekend.

Publication of performance also takes place on a monthly basis.

Areas for Future Development
