Reason for Change:	To improve the usefulness and relevancy of the data collected, to adequately reflect the current diversity of services offered by contraception and reproductive health clinics and to provide information with which to support the Sexual Health Strategy for Wales.

Background:

The KT31 return was last reviewed in 1995. The Health Statistics and Analysis Unit (HSA) of the Welsh Assembly Government collect this annual data and made significant changes to the return in order to improve the usefulness and relevancy of the data collected. The revised KT31 return is supported by the All Wales Heads of Service in Family Planning and Reproductive Health Care group.
