**Effective Date:** Effective from May '03

#### **Background:**

The Welsh Health Circulars (2002) 059 and (2003) 052 made notification of the introduction of a new waiting times collection initiative to cover referrals to specified diagnostic and therapy services. This originated from the 'Waiting Times Strategy', in July 2001, to extend the publication of waiting times to include diagnostic and therapy services.

WHC (2002) 059 covered the introduction of a pilot data collection, with WHC (2003) 052 covering the successful completion of the pilot and to formally confirm the continuation of the monthly collection.

#### **Implementation:**

The data submission is mandatory from April 2004. But, to ensure that data is available for the annual planning and performance improvement processes, monitoring of compliance will commence from December 2003.

To allow Trusts to assess and address any resourcing impact, Trusts are required to return their data to Health Solutions Wales on a monthly basis, commencing in May 2003.

#### **Effect on Data Dictionary:**

New data definitions and items will be included in Version 2.4 of the NHS Wales Data Dictionary (see **Changes** below).

#### **Detail of Return:**

The collection will be returned in the form of a spreadsheet. The file will be identified by the following naming convention:

#### DTxxxmmyy

Where: DT = Diagnostic & Therapy

xxx = Trust Code

mm = number of the month to which the data relates

yy = last two digits of the year

The data will be based on waiting times up to the last day of each month. Professions should report to the Information Department by the seventh working day of each month.

The file will have the following format:

Services that are not provided by a site should be left blank. Where a site provides a service and there are nil patients waiting, a zero should be placed under the 'Under 6 weeks' column.

#### **COMMUNITY PATIENT (DIAGNOSTIC & THERAPY SERVICES)**

(DT Waiting Times)

A patient who, whilst in receipt of services, is not an inpatient or daycase patient.

The contact may take place in the patient's home, in a health centre, or other community setting, or in a department located in hospital premises.

#### **EPISODE OF CARE (DIAGNOSTIC & THERAPY SERVICES)**

(DT Waiting Times)

An episode of care comprises one, or a series of contacts with diagnostic or therapy staff, relating to a care plan arising from an assessment or examination. The assessment or examination process is not counted. The episode of care commences when the first intervention identified in the care plan is delivered.

A patient may have concurrent episodes of care if, in the course of executing a treatment plan, a separate treatment need is identified.

# <u>DATE OF COMMENCEMENT OF EPISODE OF CARE (DIAGNOSTIC & THERAPY SERVICES)</u>

(DT Waiting Times)

The date the patient attended to commence an episode of care.

#### **SERVICE HEADING**

## (DT Waiting Times)

Name of specified diagnostic and therapy services for which the Monthly Collection of Waiting Times is based.

Specified services and therapies are:-

Radiology Cardiology Audiology Dietetics Physiotherapy Occupational Therapy Speech & Language Therapy Arts Therapies Podiatry

These are sub-divided into Service Sub Headings. See Service Sub Heading.
