To update definition of the Data Item GMC/GDC Registration Number

Version 2.5 of the Data Dictionary does not reflect the revised coding for new GMC Registration codes.

## Background:

Older GMC codes were calculated by applying an algorithm to generate a check digit as part of the number. Since late 2000, the national LR (limited registration) \& FPR (full/ provisional registration) code format changes have dropped the check digit for new GMC Registration numbers.

The current version of the NHS Wales Data Dictionary (v2.5) contains a reference to the check digit algorithm.

The Data Dictionary will be amended to clarify that the check digit is no longer used when generating new GMC codes. However, given that a significant proportion of the pre-2000 registrant population is currently practising, the algorithm will remain in the text as a reference to explain the 'build' of the old format GMC codes.

## Impact in Wales:

Version 2.6 of the Data Dictionary will include the latest coding format for new GMC Registration Codes.

The change to version 2.6 of the Data Dictionary will provide details of both coding formats of GMC/GDC Registration Number generated pre-2000 and post-2000.

Version 2.6 of the Data Dictionary will contain improved explanatory text.

## Appendix A: Amendment to data item 'GMC/GDC Registration Number'

The following is the change to the definition of data item 'GMC/GDC Registration Number' (changes highlighted in bold and underlined): -

Structure

## 1) For GMC/GDC Registration Numbers generated prior to 2000:-

Previously the full 7 digit code for a fully or provisionally registered medical practitioner included a check digit as the final character.

The check digit was calculated as follows, this is for information only: first character
$+3 x s e c o n d$ character
+7 xthird character
+1 xfourth character
$+3 x f i f t h$ character
+7 xsixth character
The check digit is then the unit digit (last digit) of the result of this calculation.
e.g.GMC code 3214213 . Check digit is computed by:
$3+(3 \times 2)+(7 \times 1)+4+(3 \times 2)+(7 \times 1)=33$
The check digit is 3 , so this is a valid code.
The General Medieal Couneil (GMC) phased out the eheek digit in 2001.
2) GMC/GDC Registraion Numbers generated following the LR (limited registration) and FPR (full/provisional registration) code format changes (late 2000), there is no calculation of a check digit.
