Summary of change:

Changes to the NHS Wales Data Dictionary to support the new national code structures for 'Independent Provider' and 'Independent Sector Healthcare Provider' site codes.

The changes will be incorporated into version 2.7 of the NHS Wales Data Dictionary due for release during mid December 2004.

This DSCN is in response to DSCN 06/2004 issued by the NHS Information Authority.

The main reasons for issuing this DSCN is to allow continuity of the mechanism for the provision of new organisation codes by Health Solutions Wales (HSW) and to maintain consistency with NHS-wide (all home countries) coding structures.

Subject:	Data Standards: Independent Healthcare Provider Coding Structures
Effective Date:	1 st November 2004
Reason of Change:	To introduce revised coding structures for independent healthcare providers and bring Wales in line with National (U.K.) standards.

Background:

Effective information management is essential to support the patient care process and it aids the development of patient focused services. In order to monitor the care delivered by the NHS and independent healthcare providers, it is necessary to include activity in the information reported and to differentiate activity between NHS providers and independent healthcare providers.

The National Administrative Codes Service (NACS) has introduced a new coding structure for independent healthcare provider sites. Nationally (U.K.), these codes are prefixed with an 'N'. Currently, NHS Wales allocates independent provider site codes with a prefix of '8'. Nationally (U.K.), independent provider site codes with a prefix of '8' are limited to registered and non-registered nursing homes, independent therapists, independent hospices and charities.

Currently, the PEDW database holds information on inpatient and day case activity provided to NHS patients, regardless of where it is delivered. Data for the PEDW database is submitted by NHS Wales Trusts using the mandated Admitted Patient Care Minimum Dataset (APCmds). One of the data items in the APCmds is 'Provider Code', which is populated with the 5-character code of the organisation providing the treatment.

Impact in Wales:

To maintain consistency with national (U.K.) standards for the format of site codes for independent healthcare providers, NHS Wales will adopt the new coding structures.

Previous codes for private hospitals within Wales, with a prefix of '8', will be made inactive from 1st January 2005. Requests for new codes must be made to Sue Morris at HSW – (<u>sue.morris@hsw.wales.nhs.uk</u>).

Recently, 'N' codes have been allocated to the following independent healthcare providers in Wales: -

Code	Independent Provider
NT1W1	Bpas (cardiff)
NT3W1	Bupa Hospital Cardiff
NT3W2	Bupa Yale Hospital
NT4W1	Bmi - Werndale Hospital
NTYW1	Llanarth Court Hospital

These codes are registered by HSW and details stored on the Reference Data table for UK Organisations. These details match information maintained by NACS.

Implications of the change to Trust's and HSW systems has been sought, but no impact has been reported (See Appendix B)
