Subject: Proposal for the increase in scope to the Diagnostic and Therapy Services Waiting Times

Reason for Change: To enable the monitoring of waits for diagnostic and therapy procedures in line with 'Designed for Life'.

Effective Date: 1st April 2007

1. <u>Background:</u>

The Access 2009 Project was established to support the achievement of the 26 week total patient pathway. This pathway covers the wait from GP or Dental referral to treatment and includes waiting times for any required diagnostic tests and therapies.

Currently waiting times are reported monthly across a range of specialities and for specified diagnostic and therapy services. However, there are a number of diagnostic tests that are not included.

Between January and March, pilot projects were undertaken to collect aggregated data on waits for 5 new diagnostic tests.

Following this pilot collection, this DSCN informs the service of the mandating of 5 additional diagnostic tests as part of the monthly Diagnostic and Therapy Services Waiting Times data collection. These tests are covered under 3 Service headings.

Guidance on the reporting structure of the Diagnostic and Therapy Services Waiting Times monthly data collections can be found in DSCN (2007) 04 (W).

2. Impact for Trusts:

- 2.1 The scope of the 5 additional diagnostic tests to be included as detailed in WHC (2007) 030.
- 2.2 From 1st April 2007, Trusts will include the aggregated counts for these additional diagnostic tests in their monthly data collection of Diagnostic and Therapy Services Waiting Times.
