DATASET CHANGE NOTICE (2007) 14 (W)

- Reference:** WIGSB 1810200701
- Subject:** To introduce OPCS 4.4 for use in NHS Wales
- Reason for Change:** To allow recording of additional clinical interventions codes and to align with similar implementations in England and Scotland.
- Implementation Date:** 1st October 2007

Background OPCS:

OPCS has been in use since 1990 and requires regular updating to reflect changes in clinical practice by allowing the recording of a broader range of interventions

Since 1st April 2007, NHS Wales utilises the Office of Population Censuses and Surveys Classification of Interventions and Procedures (OPCS) version 4.3.

On 1st April 2007, the NHS in England released OPCS version 4.4 which expands version 4.3 by an additional 241 codes (representing a 3% increase). There are 207 refinements to existing codes and descriptions to clarify meaning or to provide new includes/excludes notes, as well as improvements to sequencing notes. The Index has been improved, doubling the list of surgical abbreviations, including a new section covering High Cost Drugs and including some new anti-viral drugs. Context specificity has been removed in v4.4 which will enable Trusts to code procedures and certain high-cost drugs in whatever setting is appropriate.

It is important to have common data standards between the UK countries, particularly where there is a need for a cross-border exchange of data.

Background HRG v3.5:

A new version of the Healthcare Resource Group (HRG) Grouper 3.5 v2007.1.0 has been released to support the introduction of OPCS 4.4. This release of the v2007.1.0 Grouper continues to support all the HRG definition schemes previously supported by HRG Grouper V2006.2.1.

V2007.1.0 incorporates the latest Table of Coding Equivalence (TOCE), which maps the OPCS-4.4 codes introduced to their equivalent codes in OPCS-4.2. The design of HRGv3.5 is based on the use of OPCS-4.2 codes and HRGs cannot be derived directly from later OPCS codes. However, this does not prevent grouping. Trusts will be required to use v2007.1.0 following the implementation of OPCS 4.4 to ensure that additional codes introduced in OPCS 4.4 are grouped.

Actions required

Health Solutions Wales (HSW) will ensure:

- Training materials for the Basic Training Courses are in line with England and are adopted across Wales.
- Ensure that existing and new specialist training materials are updated to reflect the changes.
- Arrange the distribution of new Reference Books to existing clinical coders.
- Undertake any necessary updates to Reference Data tables to incorporate OPCS v4.4.

Trusts will ensure:

- Their patient administration systems and encoding systems are upgraded to incorporate OPCS v4.4 and HRG 3.5 v2007.1.0 by the date defined.
- Trusts using the READ coding system are responsible for ensuring that the mapping to OPCS incorporates the OPCS v4.4 classification
- Trusts are required to engage with their clinical and other relevant staff to raise awareness of the updated classification in order to maximise the benefits from its introduction.
