Subject: To mandate the data item 'Local Health Board' in the RTT Return

Reason for Change: To allow reporting of RTT information by the Local Health Boards in support of the 2009 Access Target.

Implementation Date: 1st April 2008

Background:

As part of Access 2009 - Delivering a 26 week Patient Pathway, the new Referral to Treatment Times monthly data collection commenced on 1st April 2007.

One condition of WIGSB approval was that this data collection should be reviewed within twelve months of implementation.

It was also agreed that the Local Health Board codes should be optional for initial data collections, as concerns were raised that organisations might find it difficult to identify the Local Health Board for inclusion in the data submission.

At the review stage, it was demonstrated that, for the majority of records submitted, the Local Health Board was identified. WIGSB therefore approved the change of status of the LHB Code in the data collection from optional to mandatory against those counts where their weekly wait bands are greater than zero. This will take effect from April 2008.

Further guidance on the reporting structure for the Referral to Treatment Time data collection can be found in DSCN (2007) 08.
